# **First-aid Measures**

#### Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. Call a Poison Centre or doctor.

#### **Skin Contact**

### **Eye Contact**

# **Extinguishing Media**

# Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog. Use water to keep non-leaking, fire-exposed containers cool.

### **Unsuitable Extinguishing Media**

Do not use a solid (straight) water stream as it may scatter and spread fire.

### **Specific Hazards Arising from the Product**

Heating increases the release of toxic vapour. Combustible dust. Powder may form explosive dust-air mixture. In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

# **Special Protective Equipment and Precautions for Fire-fighters**

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Dust explosion hazard. Use water spray or fog to prevent dust formation and minimize risk of

explosion. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

# Personal Precautions, Protective Equipment, and Emergency Procedures

Keep containers tightly closed when not in use or empty. Wash hands thoroughly after handling this product and before eating, using the washroom or leaving work area.
