## **SECTION 2. HAZARD IDENTIFICATION**

#### Inhalation

#### Suitable Extinguishing Media

#### **Specific Hazards Arising from the Product**

Does not burn. Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents.

#### **Special Protective Equipment and Precautions for Fire-fighters**

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous

vapours or gases. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

#### Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

#### **Environmental Precautions**
