Inhalation

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog. Use water to keep non-leaking, fire-exposed containers cool.

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

Benzoic Acid

Can ignite if strongly heated. Combustible dust. Powder may form explosive dust-air mixture. Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents. In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Dust explosion hazard. Use water spray or fog to prevent dust formation and minimize risk of explosion. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Do not touch spilled material. Prevent material from entering sewers or waterways. Stop or reduce leak if safe to do so. SMALL SPILLS OF MOLTEN LIQUID: Protect from heat. Soak up spill with non-combustible absorbent material which does not react with spilled chemical. Put material in suitable, covered, labelled containers. Flush area with water. Contaminated absorbent material may pose the same hazards as the spilled product.

SMALL SPILLS OF SOLID: Shovel into clean, dry, labelled containers and cover. Flush area with water.

LARGE SPILLS: Contact fire and emergency services and supplier for advice.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Avoid generating dusts. Only use where there is adequate ventilation. Prevent accidental contact with incompatible chemicals. Do not dry sweep. Wet the product or use explosion-proof HEPA vacuum. Keep containers tightly closed when not in use or empty.

Conditions for Safe Storage

Store in an area that is: cool, out of direct sunlight and away from heat and ignition sources, separate from incompatible materials (see Section 10: Stability and Reactivity).
