SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Get medical advice or attention if you feel unwell or are concerned.

Skin Contact

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. Immediately call a Poison Centre or doctor.

Eve Contact

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog. Special "alcohol resistant fire-fighting foams".

Unsuitable Extinguishing Media

None known.

Specific Hazards Arising from the Product

Combustible liquid. Can ignite if heated. Releases vapour that can form explosive mixture with air at or above the flash point. Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Approach fire from upwind to avoid hazardous vapours or gases. Move containers from fire area if it can be done without risk. Otherwise, use water in flooding quantities as a spray or fog to keep fire-exposed containers cool and absorb heat. Use water spray to flush spills away from ignition sources. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Do not touch damaged containers or spilled product unless wearing appropriate protective equipment. Remove or isolate incompatible materials as well as other hazardous materials. Increase ventilation to area or move leaking container to a well-ventilated and secure area.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain spill with earth, sand, or absorbent material which does not react with spilled material. Place used absorbent into suitable, covered, labelled containers for disposal. Flush spill area.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Avoid breathing in this product. Only use where there is adequate ventilation. Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs. Prevent accidental contact with incompatible chemicals. Keep away from clothing and other combustible materials. Keep containers tightly closed when not in use or empty.

Conditions for Safe Storage

Store in an area that is: cool, dry, well-ventilated, out of direct sunlight and away from heat and ignition sources, separate from incompatible materials (see Section 10: Stability and Reactivity), clear of combustible and flammable materials (e.g. old rags, cardboard). Store product under an inert gas such as nitrogen. Store in a closed container.
