### SECTION 4. FIRST-AID MEASURES

#### First-aid Measures

##### Inhalation

Move to fresh air. Keep at rest in a position comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

##### Skin Contact

Avoid direct contact. Wear chemical protective clothing if necessary. Immediately rinse with lukewarm, gently flowing water for 15-20 minutes.

##### Eye Contact

Immediately call a Poison Centre or doctor. Specific treatment is required. Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face.

##### Ingestion

Never give anything by mouth if person is rapidly losing consciousness, or is unconscious or convulsing. Do not induce vomiting. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the Poison Centre or doctor.

##### First-aid Comments

#### Most Important Symptoms and Effects, Acute and Delayed

## SECTION 6. ACCIDENTAL RELEASE MEASURES

### Personal Precautions, Protective Equipment, and Emergency Procedures

Get expert advice. Emergency responders: use the personal protective equipment recommended in Section 8 of this safety data sheet. Evacuate the area immediately. Isolate the hazard area.
