SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Immediately call a Poison Centre or doctor. Move to fresh air. Keep at rest in a position comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

Skin Contact

Extinguishing Media

Heating increases the release of toxic vapour.

Special Protective Equipment and Precautions for Fire-fighters

Use extreme caution. Evacuate area. Approach fire from upwind to avoid hazardous vapours or gases. Fight fire from a safe distance or a protected location. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Use non-combustible absorbent materials such as vermiculite, earth or sand to contain spilled product. Collect using shovel/scoop or approved HEPA vacuum and place in a suitable container for disposal. Cautiously dilute and neutralize with lime or soda ash. Place used absorbent into suitable, covered, labelled containers for disposal.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Avoid breathing in this product. Avoid generating vapours or mists. Only use where there is adequate ventilation. Immediately report leaks, spills or failures of the safety equipment (e.g. ventilation system). Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs. Prevent accidental contact with incompatible chemicals. Never add water to a corrosive. Always add corrosives slowly to COLD water. If product is transferred to another container, ensure new container is suitable for the product. Never reuse empty containers, even if they appear to be clean. Keep containers tightly closed when not in use or empty.

Conditions for Safe Storage

Store in an area that is: cool, dry, well-ventilated, out of direct sunlight and away from heat and ignition sources, separate from incompatible materials (see Section 10: Stability and Reactivity), clear of combustible and flammable materials (e.g. old rags, cardboard). Protect from conditions listed in Conditions to Avoid in Section 10 (Stability and Reactivity). Keep amount in storage to a minimum. Store in the original, labelled, shipping container.
