SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

Skin Contact

Immediately wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 15-20 minutes.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. If eye irritation persists, get medical advice or attention.

Ingestion

Rinse mouth with water. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Call a Poison Centre or doctor if you feel unwell.

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour.

Special Protective Equipment and Precautions for Fire-fighters

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full

protective gear. Move containers from fire area if it can be done without risk. Otherwise, use water in flooding quantities as a spray or fog to keep fire-exposed containers cool and absorb heat.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate downwind locations. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Methods and Materials for Containment and Cleaning Up

Avoid generating dust. Stop or reduce leak if safe to do so.

Small spills or leaks: collect using shovel/scoop or approved HEPA vacuum and place in a suitable container for disposal.

Large spills or leaks: avoid dry sweeping. If necessary, use a dust suppressant such as water. Do not use compressed air for clean-up. Collect using shovel/scoop or approved HEPA vacuum and place in a suitable container for disposal. Flush spill area.

Precautions for Safe Handling

Obtain special instructions before use. Avoid generating dusts. Only use where there is adequate ventilation. Wear personal protective equipment to avoid direct contact with this chemical.
