SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. Call a Poison Centre or doctor if you feel unwell.

Skin Contact

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. If skin irritation occurs, get medical advice or attention.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. If eye irritation persists, get medical advice or attention.

Ingestion

Do not induce vomiting. Rinse mouth with water. If vomiting occurs naturally, lie on your side in the recovery position. Rinse mouth with water again. Immediately call a Poison Centre or doctor.

Extinguishing Media

Specific Hazards Arising from the Product

Does not burn. Heating increases the release of toxic vapour.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

A full-body encapsulating chemical protective suit with positive pressure SCBA may be necessary. Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures
