Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog. Special "alcohol resistant fire-fighting foams".

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents. Combustible dust. Powder may form explosive dust-air mixture.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide; very toxic, flammable formaldehyde.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire remotely due to the risk of explosion. Dust explosion hazard. Use water spray or fog to prevent dust formation and minimize risk of explosion. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.
