SECTION 2. HAZARD IDENTIFICATION

Use explosion-proof electrical, ventilating, and lighting equipment.

Use non-sparking tools.

Take action to prevent static discharges.

Avoid breathing dust/fume/gas/mist/vapours/spray.

Wash hands and skin thoroughly after handling.

Use only outdoors or in a well-ventilated area.

Wear protective gloves/protective clothing/eye protection/face protection.

Response:

IF SWALLOWED: Call a POISON CENTRE or doctor if you feel unwell.

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting.

IF ON SKIN: Wash with plenty of water.

IF INHALED: Remove person to fresh air and keep comfortable for breathing.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor. Seek immediate medical attention.

Skin Contact

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. Immediately call a Poison Centre or doctor.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Immediately call a Poison Centre or doctor. Specific treatment is required.

Ingestion

Rinse mouth with water. Do not induce vomiting. If vomiting occurs, have person lie on side in the recovery position. Rinse mouth with water again. Immediately call a Poison Centre or doctor.

First-aid Comments

Consult a doctor and/or the nearest Poison Control Centre for all exposures except under minor instances of inhalation or skin contact.

Most Important Symptoms and Effects, Acute and Delayed

If swallowed: can burn the lips, tongue, throat and stomach. Symptoms may include nausea, vomiting, stomach cramps and diarrhea. If in eyes: contact causes severe burns with redness, swelling, pain and blurred vision. Permanent damage including blindness can result. If on skin: contact can cause pain, redness, burns, and blistering. Permanent scarring can result.

SECTION 5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

May travel a considerable distance to a source of ignition and flash back to a leak or open container. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide; corrosive, oxidizing nitrogen oxides.

Special Protective Equipment and Precautions for Fire-fighters

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full

protective gear. Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Move containers from fire area if it can be done without risk. Otherwise, use water in flooding quantities as a spray or fog to keep fire-exposed containers cool and absorb heat. Use water spray to dilute spills to non-flammable mixtures. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources. Use grounded, explosion-proof equipment. Remove or isolate incompatible materials as well as other hazardous materials. Notify government occupational health and safety and environmental authorities.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway. If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas.

Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain spill with earth, sand, or absorbent material which does not react with spilled material.

Small spills or leaks: contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal. Flush spill area.

Large spills or leaks: contact emergency services and manufacturer/supplier for advice.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Avoid breathing in this product. Only use

where there is adequate ventilation. Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs. Use non-sparking tools. Never add water to a corrosive. Always add corrosives slowly to COLD water. Prevent accidental contact with incompatible chemicals. Keep containers tightly closed when not in use or empty.

Conditions for Safe Storage

Store in an area that is: cool, dry, well-ventilated, out of direct sunlight and away from heat and ignition sources, separate from incompatible materials (see Section 10: Stability and Reactivity). Keep amount in storage to a minimum. Protect from conditions listed in Conditions to Avoid in Section 10 (Stability and Reactivity). Store in the original, labelled, shipping container.

"SKIN" NOTATION: Contact with skin, eyes, and mucous membranes can contribute to the overall exposure and may invalidate the TLV. Consider measures to prevent absorption by these routes.

Appropriate Engineering Controls

Use local exhaust ventilation and enclosure, if necessary, to control amount in the air. Provide eyewash and safety shower if contact or splash hazard exists. Use non-sparking ventilation systems, approved explosion-proof equipment and intrinsically safe electrical systems in areas where this product is used and stored.
