SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. If experiencing respiratory symptoms (e.g. coughing, shortness of breath, wheezing), call a Poison Centre or doctor.

Skin Contact

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. If skin irritation occurs, get medical advice or attention.

Eve Contact

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Move containers from fire area if it can be done without risk. Otherwise, use water in flooding quantities as a spray or fog to keep fire-exposed containers cool and absorb heat. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials. Eliminate all ignition sources if safe to do so.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Small spills or leaks: wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Large spills or leaks: dike spilled product to prevent runoff. Contain and soak up spill with absorbent that does not react with spilled product. Use non-combustible absorbent materials such as vermiculite, earth or sand to contain spilled product. Place used absorbent into suitable, covered, labelled containers for disposal.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Avoid breathing in this product. Only use where there is adequate ventilation. Avoid release to the environment. Prevent accidental contact with incompatible chemicals. Keep containers tightly closed when not in use or empty. Wash hands thoroughly after handling this material.

Conditions for Safe Storage

Store in an area that is: well-ventilated, separate from incompatible materials (see Section 10: Stability and Reactivity), out of direct sunlight and away from heat and ignition sources. Store in the original, labelled, shipping container.
