Inhalation

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Knock down vapours or gases with water fog or fine water spray. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Evacuate downwind locations. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Methods and Materials for Containment and Cleaning Up

Contain spill with earth, sand, or absorbent material which does not react with spilled material. Place used absorbent into suitable, covered, labelled containers for disposal.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling
