SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor. Get immediate medical advice or attention.

Skin Contact

Avoid direct contact. Wear chemical protective clothing if necessary. Rinse with lukewarm, gently flowing water for 5 minutes. Immediately call a Poison Centre or doctor.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Immediately call a Poison Centre or doctor.

Ingestion

Do not induce vomiting. Rinse mouth with water. If breathing has stopped, trained personnel should immediately begin rescue breathing. Immediately call a Poison Centre or doctor. Specific treatment is required.

Closed containers may rupture violently when heated releasing contents. Can be ignited by static discharge. May travel a considerable distance to a source of ignition and flash back to a leak or open container. May accumulate in hazardous amounts at ceilings and at the top of confined spaces, resulting in a fire and/or health hazard. In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide. Peroxides.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Before entry, especially into confined areas, use an appropriate monitor to check for: toxic gases or vapours, flammable or explosive atmosphere, sufficient oxygen. Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Evacuate downwind locations. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources if safe to do so. Remove or isolate incompatible materials as well as other hazardous materials. May collect in hazardous amounts, at ceilings and at the top of confined spaces, if ventilation is not sufficient. Before entry, especially into confined areas, check atmosphere with an appropriate monitor. Monitor area for flammable or explosive atmosphere.

Environmental Precautions

Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain spill with earth, sand, or absorbent material which does not react with spilled material.

Small spills or leaks: place used absorbent into suitable, covered, labelled containers for disposal. Large spills or leaks: contact emergency services and manufacturer/supplier for advice.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Obtain special instructions before use. Wear personal protective equipment to avoid direct contact with this chemical. Immediately report leaks, spills or failures of the safety equipment (e.g. ventilation system). Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Prevent accidental contact with incompatible chemicals. Avoid generating vapours or mists. Avoid release to the environment. Inspect container and lid carefully for damage, leaks or signs of peroxide crystallization before handling. Never return unused or contaminated product to its original container. Keep containers tightly closed when not in use or empty. Wash hands thoroughly after handling this material.
