SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Most Important Symptoms and Effects, Acute and Delayed

Special Protective Equipment and Precautions for Fire-fighters

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions
