SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. Get medical advice or attention if you feel unwell or are concerned.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a safe distance or a protected location. Oxidizer. Prevent contact with flammable and combustible materials. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Use water spray to flush spills away from ignition sources. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Emergency responders: use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.
