SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

SECTION 5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog. Special "alcohol resistant fire-fighting foams". Use water to keep non-leaking, fire-exposed containers cool.

Unsuitable Extinguishing Media

None known.

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents. Liquid can float on water and may travel to distant locations and/or spread fire.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Use water spray to dilute spills to non-flammable mixtures. Use water spray to flush spills away from ignition sources. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Methods and Materials for Containment and Cleaning Up

Contain spill with earth, sand, or absorbent material which does not react with spilled material. Remove or recover liquid using pumps or vacuum equipment. Place used absorbent into suitable, covered, labelled containers for disposal. Small spills or leaks: contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal. Flush spill area. Large spills or leaks: contact emergency services and manufacturer/supplier for advice.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs. Do not weld, cut or perform hot work on empty container until all traces of product have been removed. Prevent accidental contact with incompatible chemicals. Keep smallest practical amount in work area. Avoid generating vapours or mists. Keep away from clothing and other combustible materials. Never return unused or contaminated product to its original container. Keep containers tightly closed when not in use or empty.

Conditions for Safe Storage

Store in an area that is: cool, dry, well-ventilated, out of direct sunlight and away from heat and ignition sources, separate from incompatible materials (see Section 10: Stability and Reactivity), clear of combustible and flammable materials (e.g. old rags, cardboard). Keep amount in storage to a minimum. Protect from conditions listed in Conditions to Avoid in Section 10 (Stability and Reactivity). Store in the original, labelled, shipping container.
