# **SECTION 4. FIRST-AID MEASURES**

### **First-aid Measures**

#### Inhalation

Remove source of exposure or move to fresh air. If experiencing respiratory symptoms (e.g. coughing, shortness of breath, wheezing), call a Poison Centre or doctor. If breathing has stopped, trained personnel should begin rescue breathing.

### **Extinguishing Media**

### Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Do not use a solid (straight) water stream as it may scatter and spread fire.

### Specific Hazards Arising from the Product

Heating increases the release of toxic vapour.

Very toxic carbon monoxide, carbon dioxide.

### **Special Protective Equipment and Precautions for Fire-fighters**

Evacuate area. Move containers from fire area if it can be done without risk. Otherwise, use water in flooding quantities as a spray or fog to keep fire-exposed containers cool and absorb heat. As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full

protective gear. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

# **SECTION 6. ACCIDENTAL RELEASE MEASURES**

### Personal Precautions, Protective Equipment, and Emergency Procedures

Emergency responders: evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Evacuate downwind locations. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources. Use grounded, explosion-proof equipment. Remove or isolate incompatible materials as well as other hazardous materials.

#### **Environmental Precautions**

Do not allow into any sewer, on the ground or into any waterway.

### Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain and soak up spill with absorbent that does not react with spilled product. (e.g. earth, sand). Collect using shovel/scoop or approved HEPA vacuum and place in a suitable container for disposal.

### **Precautions for Safe Handling**

Wear personal protective equipment to avoid direct contact with this chemical. Only use where there is adequate ventilation. Immediately report leaks, spills or failures of the safety equipment (e.g. ventilation system). Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Electrically bond and ground equipment. Ground clips must contact bare metal. Prevent accidental contact with incompatible chemicals. Keep containers tightly closed when not in use or empty.

Store in an area that is: cool, well-ventilated, separate from incompatible materials (see Section 10: Stability and Reactivity). Electrically bond and ground containers. Ground clips must contact bare metal.
