Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Unsuitable Extinguishing Media

Do not use a solid (straight) water stream as it may scatter and spread fire.

Specific Hazards Arising from the Product

Thermal decomposition can lead to release of irritating gases and vapours.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide; corrosive, oxidizing nitrogen oxides.

Special Protective Equipment and Precautions for Fire-fighters

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full

protective gear. Move containers from fire area if it can be done without risk. Otherwise, use water in flooding quantities as a spray or fog to keep fire-exposed containers cool and absorb heat. Approach fire from upwind to avoid hazardous vapours or gases. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.
