### **SECTION 4. FIRST-AID MEASURES**

#### **First-aid Measures**

#### Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

#### Skin Contact

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. If skin irritation occurs, get medical advice or attention.

### **Eye Contact**

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. If eye irritation persists, get medical advice or attention.

#### Ingestion

Rinse mouth with water. Do not induce vomiting. Immediately call a Poison Centre or doctor.

# **Extinguishing Media**

### Specific Hazards Arising from the Product

Highly flammable liquid and vapour. Can ignite at room temperature. Releases vapour that can form explosive mixture with air. May travel a considerable distance to a source of ignition and flash back to a leak or open container. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, resulting in a fire hazard. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

# **Special Protective Equipment and Precautions for Fire-fighters**

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Stop leak before attempting to put out the fire. Product could form an explosive mixture and reignite. If the leak cannot be stopped, let the fire burn itself out. Use water spray to dilute spills to non-flammable mixtures. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal. Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

### **SECTION 6. ACCIDENTAL RELEASE MEASURES**

# Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Evacuate downwind locations. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources if safe to do so. Remove or isolate incompatible materials as well as other hazardous materials. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, if ventilation is not sufficient. Distant ignition and flashback are possible.

#### **Environmental Precautions**

Do not allow into any sewer, on the ground or into any waterway.

# Methods and Materials for Containment and Cleaning Up

Small spills or leaks: use non-combustible absorbent materials such as vermiculite, earth or sand to contain spilled product. Place used absorbent into suitable, covered, labelled containers for disposal.

Large spills or leaks: contain spill with earth, sand, or absorbent material which does not react with spilled material. Remove or recover liquid using pumps or vacuum equipment.

### **SECTION 7. HANDLING AND STORAGE**

### **Precautions for Safe Handling**

Wear personal protective equipment to avoid direct contact with this chemical. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Prevent accidental contact with incompatible chemicals. Avoid generating vapours or mists. Electrically bond and ground equipment. Ground clips must contact bare metal. Use non-sparking tools. Never return unused or contaminated product to its original container. Keep containers tightly closed when not in use or empty. It is good practice to: avoid breathing product; avoid skin and eye contact and wash hands after handling.

### **Conditions for Safe Storage**

Store in an area that is: cool, dry, well-ventilated, out of direct sunlight and away from heat and ignition sources, separate from incompatible materials (see Section 10: Stability and Reactivity). Keep amount in storage to a minimum. Store in the original, labelled, shipping container. Protect from conditions listed in Conditions to Avoid in Section 10 (Stability and Reactivity).
