Hazard Statement(s): Highly flammable liquid and vapour. Causes serious eye irritation. Suspected of causing genetic defects. May cause cancer.

Precautionary Statement(s): Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Keep container tightly closed. Ground/bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting//equipment. Use only non-sparking tools. Take action to prevent static discharges. Do not breathe dust/fume/gas/mist/vapours/spray. Wash hands thoroughly after handling.

Wear protective gloves/protective clothing/eye protection/face protection.

SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

Skin Contact

Wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 5 minutes. If skin irritation occurs, get medical advice or attention.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. If eye irritation persists, get medical advice or attention.

Ingestion

Do not induce vomiting. Never give anything by mouth if person is rapidly losing consciousness, or is unconscious or convulsing. Do not induce vomiting. Rinse mouth with water. Immediately call a Poison Centre or doctor.

SECTION 5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

Reactive flammable. Can be ignited by static discharge. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Before entry, especially into confined areas, use an appropriate monitor to check for: toxic gases or vapours. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources if safe to do so. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, if ventilation is not sufficient.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Small spills or leaks: contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Do not get in eyes, on skin or on clothing. Only use where there is adequate ventilation. Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs.
