Specific Hazards Arising from the Product

Heating increases the release of toxic vapour.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a safe distance or a protected location. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Approach fire from upwind to avoid hazardous vapours or gases. Knock down vapours or gases with water fog or fine water spray.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

A full-body encapsulating chemical protective suit with positive pressure SCBA may be necessary.
