SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. If

experiencing respiratory symptoms (e.g. coughing, shortness of breath, wheezing), call a Poison Centre or doctor. **Skin Contact**

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. If skin irritation occurs, get medical advice or attention.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. If eye irritation persists, get medical advice or attention.

Ingestion

Do not induce vomiting. Rinse mouth with water. If vomiting occurs, have person lie on side in the recovery position. Rinse mouth with water again. Immediately call a Poison Centre or doctor.

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Knock down vapours or gases with water fog or fine water spray.

A full-body encapsulating chemical protective suit with positive pressure SCBA may be necessary. Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures
