Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. If possible, isolate materials not yet involved in the fire, and move containers from fire area if this can be done without risk, and protect personnel. Otherwise, water spray or fog can be used to absorb heat, keep fire-exposed containers or tanks cool and protect exposed material.

Personal Precautions, Protective Equipment, and Emergency Procedures

Methods and Materials for Containment and Cleaning Up

Small spills of solids: avoid generating dust. Collect using shovel/scoop or approved HEPA vacuum and place in a suitable container for disposal. Flush spill area.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Obtain special instructions before use. Only use where there is adequate ventilation. Avoid generating vapours or mists.
