SECTION 4. FIRST-AID MEASURES

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. Immediately call a Poison Centre or doctor.

Skin Contact

Immediately rinse skin with lukewarm, gently flowing water for at least 30 minutes. Immediately call a Poison Centre or doctor.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Immediately call a Poison Centre or doctor and follow their advice.

Ingestion

Do not induce vomiting. Rinse mouth with water. Immediately call a Poison Centre or doctor. Specific treatment is required.

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour.

In a fire, the following hazardous materials may be generated: Silicon oxide, sodium oxide and possibly sodium.

Special Protective Equipment and Precautions for Fire-fighters

Approach fire from upwind to avoid hazardous vapours or gases. Fight fire from a safe distance or a protected location. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Methods and Materials for Containment and Cleaning Up
