SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Move to fresh air. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

Skin Contact

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures
