First-aid Measures

Inhalation

Move to fresh air. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor. Call a Poison Centre or doctor.

Special Protective Equipment and Precautions for Fire-fighters
