SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by Poison Centre or doctor.

Skin Contact

Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. If skin irritation occurs, get medical advice or attention.

Eye Contact

Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Immediately call a Poison Centre or doctor.

Ingestion

Do not induce vomiting. Rinse mouth with water. If vomiting occurs, have person lie on side in the recovery position. Rinse mouth with water again, Immediately call a Poison Centre or doctor.

Oxidizer. May intensify fire. Releases oxygen to create an oxygen-rich atmosphere. Will cause combustible materials to ignite more readily. Closed containers may rupture violently when heated releasing contents. Corrosive, oxidizing nitrogen oxides.

Special Protective Equipment and Precautions for Fire-fighters

Oxidizer. Prevent contact with flammable and combustible materials. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

A full-body encapsulating chemical protective suit with positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Emergency responders: evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Evacuate downwind locations. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Avoid generating dust. Contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal.
