Extinguishing Media

Specific Hazards Arising from the Product

Closed containers may rupture violently when heated releasing contents. Heating increases the release of toxic vapour.

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Emergency responders: use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Collect using shovel/scoop or approved HEPA vacuum and place in a suitable container for disposal.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Only use where there is adequate ventilation. Avoid generating dusts. Wear personal protective equipment to avoid direct contact with this chemical. Prevent accidental contact with incompatible chemicals. If product is transferred to another container, ensure new container is suitable for the product. Never return unused or contaminated product to its original container. Keep containers tightly closed when not in use or empty.

Conditions for Safe Storage

Store in an area that is: cool, dry, ventilated, separate from incompatible materials (see Section 10: Stability and Reactivity). Store in the original, labelled, shipping container.
