### SECTION 2. HAZARD IDENTIFICATION

### **SECTION 4. FIRST-AID MEASURES**

#### **First-aid Measures**

##### **Inhalation**

Remove source of exposure or move to fresh air. Seek immediate medical attention.

##### **Skin Contact**

Immediately wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 15-20 minutes. Immediately call a Poison Centre or doctor.

##### **Eye Contact**

Rinse the contaminated eye(s) with lukewarm, gently flowing water for 5 minutes, while holding the eyelid(s) open. Contact physician immediately.

##### **Ingestion**

Rinse mouth with water. Do not induce vomiting. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Immediately call a Poison Centre or doctor.

##### **First-aid Comments**

Provide general supportive measures (comfort, warmth, rest). All first aid procedures should be periodically reviewed by a doctor familiar with the material and its condition of use in the workplace.

## SECTION 5. FIRE-FIGHTING MEASURES

### Extinguishing Media

#### Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

#### Unsuitable Extinguishing Media

Water may be ineffective for extinguishing a fire because it may not cool cyclohexane below its flash point.

### Specific Hazards Arising from the Product

Highly flammable liquid and vapour. Can ignite at room temperature. Releases vapour that can form explosive mixture with air. May travel a considerable distance to a source of ignition and flash back to a leak or open container. Can accumulate static charge by flow, splashing or agitation. Liquid can float on water and may travel to distant locations and/or spread fire. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide; toxic, flammable aldehydes.

### Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Stop leak before attempting to put out the fire. Product could form an explosive mixture and reignite. Use water spray to flush spills away from ignition sources. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal. Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

### Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate downwind locations. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Do not touch damaged containers or spilled product unless wearing appropriate protective equipment. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Eliminate all ignition sources. Use grounded, explosion-proof equipment. Remove or isolate incompatible materials as well as other hazardous materials. Notify government occupational health and safety and environmental authorities.

### Environmental Precautions

Do not allow into any sewer, on the ground or into any waterway. If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas.

### Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain spill with earth, sand, or absorbent material which does not react with spilled material.

Small spills or leaks: contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal.

Large spills or leaks: contact emergency services and manufacturer/supplier for advice.

## SECTION 7. HANDLING AND STORAGE

### Precautions for Safe Handling

Wear personal protective equipment to avoid direct contact with this chemical. Only use where there is adequate ventilation. Eliminate heat and ignition sources such as sparks, open flames, hot surfaces and static discharge. Post "No Smoking" signs. Electrically bond and ground equipment. Ground clips must contact bare metal. Keep smallest practical amount in work area. Prevent accidental contact with incompatible chemicals. Never return unused or contaminated product to its original container. Keep containers tightly closed when not in use or empty.

### Appropriate Engineering Controls

Use local exhaust ventilation and enclosure, if necessary, to control amount in the air. Use non-sparking ventilation systems, approved explosion-proof equipment and intrinsically safe electrical systems in areas where this product is used and stored. Exhaust directly to the outside, taking any necessary precautions for environmental protection.

### Individual Protection Measures

#### Eye/Face Protection

Wear chemical safety goggles and face shield when contact is possible.

#### Skin Protection

Wear chemical protective clothing e.g. gloves, aprons, boots.

Suitable materials are: nitrile rubber, Viton®, Viton®/butyl rubber, Silver Shield®, Frontline® 500, Tychem® F, Tychem® ThermoPro, Tychem® BR/LV, Tychem® TK, Tychem® Reflector, Zytron® 300, Zytron® 500.

#### Respiratory Protection
